ORDINANCE NO. 67-17

VILLAGE OF CENTERVILLE, OHIO

AN ORDINANCE AWARDING AN EXCLUSIVE FRANCHISE FOR THE COLLECTION OF RESIDENTIAL TRASH AND GARBAGE WITHIN THE VILLAGE OF CENTERVILLE FOR A TERM OF THREE YEARS BEGINNING OCTOBER 29, 1967.

WHEREAS, the last contract and exclusive franchise for the collection of residential trash and garbage in the Village of Centerville expired on October 28, 1967; and

WHEREAS, the Village of Centerville had duly published a Notice to Bidders requesting sealed bids be submitted for a new three year contract and exclusive franchise for such work; and

WHEREAS, no bids were received in response to said Notice; and

WHEREAS, the Council of the Village of Centerville by appropriate action resolved to award an exclusive franchise for the collection of residential trash and garbage in the Village of Centerville to Roogler's Refuse Collection, Inc., at a rate of \$2.50 per month per household for a term of three years beginning October 29, 1967, and subject to approval by the Village Council of the terms and conditions of a contract negotiated by said Company and the officers of the Village of Centerville; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE:

SECTION 1. An exclusive franchise for the collection of residential trash and garbage in the Village of Centerville for a term of three years beginning October 29, 1967, is hereby awarded to Koogler's Refuse Collection, Inc., upon the terms and conditions of the contract dated OCL. 27, 1967, attached hereto and made a part hereof as fully as if rewritten herein, which said terms and conditions are hereby approved and the contract and the actions of the officers of the Village in entering into same on behalf of the Village are hereby approved, ratified, and confirmed.

SECTION 2. This ordinance is hereby declared to be an emergency measure and shall take effect immediately upon its passage. An emergency is declared to exist because of the immediate need for trash and garbage collection from residences in the Village of Centerville in order to avoid a serious threat

to the health, safety and welfare of the residents of the Village which would result from the accumulation of trash and garbage.
