

ORDINANCE NO. 4-68

AN ORDINANCE AMENDING CODIFIED ORDINANCE SECTION 24.34 RELATING TO DESIGNATION OF STOP STREETS *& declaring an emergency.*

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CENTERVILLE, STATE OF OHIO, THAT:

SECTION 1. Section 24.34 of the Codified Ordinances, of the Village of Centerville, Ohio, is hereby amended to read as follows:

Section 24.34 Through highways; stop streets.

a. All state routes and all sections of streets and highways on which are operated streetcars, trackless trolleys or motor coaches for carrying passengers for hire along a fixed or regular route, are hereby designated as through highways provided that stop or yield signs shall be erected at all intersections with such through highways by the mayor; provided, however, that where two or more through highways intersect and no traffic control signal is in operation stop or yield signs shall be erected at one or more entrances thereto by the department of highways or the mayor.

b. The mayor may designate additional through highways and shall erect stop or yield signs on all streets and highways intersecting such through highways, or may designate any intersection as a stop intersection and shall erect like signs at one or more entrances to such intersection.

c. Every said sign shall bear the word "Stop" or "Yield" in letters not less than six inches in height. Every stop or yield sign shall be located as near as practicable at the property line of the highway at the entrance to which the stop or yield must be made, or at the nearest line of the crosswalk thereat, or, if none, at the nearest line of the roadway.

d. Every operator of a vehicle shall stop or yield the right-of-way at such sign or at a clearly marked stop or yield line before entering an intersection except when directed to proceed by a police officer or traffic-control signal.

e. The operator of a vehicle shall stop or yield the right-of-way in obedience to a stop or yield sign at any intersection where such sign is erected and shall yield the right-of-way to all other vehicles not so obligated to stop or yield.

SECTION 2. Existing Section 24.34 of the Codified Ordinances of the Village of Centerville, Ohio, is hereby repealed.

SECTION 3. This ordinance is hereby declared to be an emergency measure for the reason that it is necessary to give the Mayor immediate authority to locate yield signs on certain intersections in the Village of Centerville, Ohio, for the preservation of the public, peace, health and safety, and shall take effect and be in full force from and after the date of its passage, the earliest period allowed by law.
