It was moved by Mr. Schweizer, Seconded by Mr. Puterbaugh

and carried that Ordinance No. 5- 1943, being "an ordinance to regulate and restrict the height, number of stories and size of buildings, the percentage of lot that may be occupied, the size of yards, courts, and other open spaces, the density of population, the location and use of buildings and land for trade, industry, residence or other purposes; to create districts for said purposes and to establish the boundaries thereof; to promote the public health, safety, convenience, comfort, prosperity or general welfare by lessening congestion in the streets, securing safety from fire, panic and other dangers; to provide adequate light and air; to preventthe overcrowding of land; to avoid undue congestion of population; to facilitate the adequate provision for transpertation, water, sewage, schools, parks, and other public requirements; and to provide for enforcement and the imposition of penalties,"

be brought before the council for consideration.

Thereupon, Mr. McClure introduced Ordinance No. 5-1943 It was moved by Mr. Schell, seconded by Mr. Fox and carried that the statutory rule requiring ordinances and resolutions to be read on three separate days be dispensed with so that Ordinance No. 5- 1943 may be given its second and third readings. A roll call was ordered which resulted in five ayes being cast in avor of the motion . Those voting in the affirmative were Messrs. Schell, Fox, Schweizer, McClure, and Puterbaugh. Said Ordinance No. 5- 1943 was then given its second

and third readings.

Mr. Puterbaugh moved that said Ordinance No. 5- 1943 be passed, seconded by Mr. Schweizer and carried. A roll call was ordered which resulted in five ayes being cast in favor of the motion. Those voting in th3 affirmative were Messrs. Puterbaugh, Schweizer, Schell, Fox and McClure.

It was moved by Mr. McClure, seconded by Mr. Schell and carried that the meeting adjourn.
