MINUTES OF ORGANIZATION MEETING OF COUNCIL

The newly elected members of the Council of the Village of Centerville, in the County of Montgomery and the State of Ohio, met in the Council Chamber on Tuesday evening, January 1, 1946 at 7:30 o'clock for the purpose of organization. Present: Messrs. J. Mason McClure, Grafton E. Shawen, Don Schell, Robt. H. Fox, W.W. Lawson and Robert J. Schweizer with Mayor E.W. Bradstreet presiding.

The Mayor opened the meeting with prayer.

Thereupon the following oath of office was taken by the members of Council:

A roll call was ordered which resulted in "six eyes" being cast in favor of the motion. Those voting in the affirmative were McClure, Shawen, Fox, Schell, Puterbaugh and Schweizer.

Mr. Shawen reported bad conditions on the sidewalks and streets due to ice accumulations in front of Center Drug Store and considerable trash and litter left by the newsboys in front of the Centerville Market.

It was moved by Mr. McClure, seconded by Mr. Schell and carried that the meeting adjourn.
