The Council of the Village of Centerville, County of Montgomery and the State of Ohio, met in regular session on Monday November 13, 1944 at 8:00 o'clock inn the Council Chamber. Present: Messrs. J.Mason McClure, Robert J. Schweizer, Grafton E. Shawen and Robert H. Fox.

The minutes of the meeting held October 23, 1944, were read and approved.

It was moved by Mr. McClure, that the Resolution No. 5-1944, being a resolution "accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the County Auditor" be passed. Seconded by Mr. Schweizer and carried. A roll call was ordered which resulted in 4 "ayes being cast in favor of the motion. Those voting in the affirmative were Mr. McClure, Schwiezer, Shawen and Fox.

The council ordered the clerk to write a contract to Heber Tejan for the surfacing of Martha Ave, Lucas Dr., Laura Ave., and East Avenue, as specified by the Village Council, using tar @ 15.6¢ per gallon amounting to \$995.28 and #6 stone @ \$2.06 per T. amounting to \$290.00, making a total of \$1285.28. Mr. McClure made the above motion, seconded by Mr. Shawen and carried. A roll call was ordered which resulted in 4 "ayes" being cast in favor of the motion. Those



voting in the affirmative were Mr. McClure, Shawen, Schweizer and Fox.
