## MINUTES OF REGULAR MEETING OF THE COUNCIL

The regular meeting of the Council of the Village of Centerville, in the County of Montgomery and State of Ohio, was held in the Council Chamber on Monday evening, April 13, 1942 at 7:30 o'clock. Present: Messrs. Walter H. Woods, Thomas J. Davis, Robert Schweizer, Grafton E. Shawen and George E. Howe with Mayor Emory W. Bradstreet presiding. Mr. Daniel C. McCoy was absent from the Village.

It was moved by Mr. Shawen, seconded by Mr. Schweizer and carried that the reading of the minutes of the last meeting be dispensed.

The Mayor submitted his monthly report dated April 4, 1942 of fines, forfeitures and costscollected in Ordinance Cases during the month of March, 1942, showing the sum of \$281.35 to have been paid into the municipal treasury. It was moved by Mr. Schweizer, seconded by Mr. Shawen and unanimously carried that said report be accepted and placed on file. A roll call was ordered, which resulted in five "ayes" being cast in favor of the motion. Those voting in the affirmative being Messrs. Woods, Davis, Schweizer, Shawen and Howe.

It was moved by Mr. Schweizer, seconded by Mr. Howe and carried that the following bills be approved for payment:

A roll call was ordered, which resulted in five "ayes" being cast in the favor of the motion. Those voting in the affirmative being Messrs. Woods, Pavis, Schweizer, Shawen, and Howe.

The Mayor presented the resignation of Mr. Kichard Turner as a member of the Board of Trustees of Public Affairs of the Village of Centerville.

A general discussion ensued with respect to the continued blocking of the alley leading from Franklin Street into the residence if Mr. Arthur Compton. The general sense of the meeting was that the Solicitor should proceed to straighten the situation out.

Mr. Schweizer thereupon introduced Resolution No. 4-1942, being a resolution "Declaring it necessart to improve Martha Avanue between Main Street and East Rvenue by construction Curb and Gutter on the north side thereon between East Avenue and the West line of the north and south alley bewteen Lucas Drive and Main Street and by constructing said street between Main Street and East Evenue to the grade established by Ordinance No. 6-1941, duly passed by the Council on the 12th day of May, 1941, which construction sahll consist of not less than four (4") inches of thoroughly compacted slag, gravel, water-bound macadam, soil-cement or the equivalent, and a top dressing of not less than two (2") inches of gravel or crushed stone screeings bound with penetration asphalt or road oil applied at the rate of one-half (1/2) gallon per square yard", which resolution was give its first reading.

Mr. Woods then made the following motion: I move that the statutory rule requiring ordinances and resolutions to be read on three separate and distinct days be dispensed with, so that the said Resolution No. 4-1942 may be given its second and third readings. Said motion was then given its second and third reading.

The question being shall said Resolution No. 4 -1942 pass.

It was moved by Mr. Shawen, seconded by Mr. Howe and carried to that said resolution pass. A roll call was ordered, which resulted in five "ayes" being cast in favor of the motion. Those voting

in the affirmative were Messrs. Woods, Davis, Schweizer, Shawen and Howe.

It was moved, seconded and carried, that the meeting adjourn.
