MINUTES OF REGULAR MEETING OF THE COUNCIL.

The Council of the Village of Centerville, in the County of Montgomery and State of Ohio, met in regular session on Monday evening, February 24, 1941 at 7:30 o'clock in the Council Chamber.

Present: Messrs. Walter H. Woods, Thomas J. Davis, Joseph S. Lucas, Grafton E. Shawen, Lloyd Hibberd and Franklin Zimmerman with Mayor Emory W. Bradstreet presiding.

The minutes of the regular meeting of February 10, 1941 were read and approved.

Ordinance No. 2-1941, being "An Ordinance Regulating Blasting Operations in the Village of Centerville," was given its second reading. Mr. Zimmerman then made the following motion, " I move that the statutory rule requiring Ordinances and Resolutions to be read on three separate and distinct days be dispensed with, so that Ordinance No. 2-1941 maybe given its second and third reading." Said motion was seconded by Mr. Hibberd and carried. A roll call was ordered which resulted in six "ayes" being cast in favor of the motion. Those voting in the affirmative were Messrs.
