

REGULAR MEETING OF THE COUNCIL.

The Council of the Village of Centerville, in the County of Montgomery and State of Ohio, met in regular session on Monday evening, July 14, 1941 at 7:30 o'clock in the Council Chamber.

Present: Messrs. Walter H. Woods, Joseph S. Lucas, Grafton E. Shawen, Thomas J. Davis and Franklin Zimmerman with Walter H. Woods, President of Council, presiding in the absence of Mayor Emory W. Bradstreet. Mr. Lloyd Hibberd was absent.

The minutes of the regular meeting held June 23, 1941 were read and approved.
