

MINUTES OF SPECIAL MEETING OF THE COUNCIL

A special meeting of the Council of the Village of Centerville, was held Thursday evening, October 23, 1941 in the Town Hall. Those present were Mayor Bradstreet, Messrs. Davis, Lucas, Schweizer, Shawen, Woods and Zimmerman. Meeting with the Council were the Trustees of Washington Township, Messrs. Weidner, Miller and Gephart.

The purpose of this meeting was to discuss the re-organization of the joint Village and Township Fire Department and to select a new Fire Chief. Mr. Campbell was offered the position and accepted it at a salary of \$50.00 per month; \$25.00 of which is to be met by the Village and \$25.00 by the Township.

Messrs. Keough, Compton and Holliday attended the meeting and took part in the discussion. Mayor Bradstreet and the Trustees named the following committee to work with Mr. Campbell: Mr. Byron Himes, assistant chief, Mr. Shawen and Mr. Keough.

MINUTES OF REGULAR MEETING OF THE COUNCIL

The Council of the Village of Centerville, in the County of Montgomery and State of Ohio, met in regular session on Monday evening, October 27, 1941 at 7:30 o'clock in the council chamber.

Present: Messrs. Walter H. Woods, Thomas J. Davis, Joseph S. Lucas, Grafton E. Shawen, Robert J. Schweizer, and Franklin Zimmerman, with Mayor Emory W. Bradstreet presiding.

It was moved by Mr. Schweizer, seconded by Mr. Shawen and carried that the Village of Centerville pay \$25.00 per month of the fire chief's monthly salary of \$50.00 beginning with November, 1941. A roll call was ordered which resulted in six "ayes" being cast in favor of the motion. Those voting in the affirmative

were Messrs. Woods, Davis, Lucas, Shawen, Schweizer and Zimmerman.

It was moved by Mr. Lucas, seconded by Mr. Zimmerman and carried that the following bills be approved for payment:
