MINUTES OF SPECIAL MEETING OF THE COUNCIL

The Council of the Village of Centerville, in the County of Montgomery, and State of Ohio met in special session on Thursday evening, October 30, 1941 at 7:00 o'clock in the council chamber.

Present: Messrs. Walter H. Woods, Thomas J. Davis, Joseph S. Lucas, Grafton E. Shawen, and Robert J. Schweizer, with Mayor Emory W. Bradstreet presiding. Mr. Franklin Zimmerman was absent.

Ordinance No. 8-1941, being "An Ordinance determining to proceed with the improvement of Weller Avenue from Main Street to East Avenue by constructing curb and gutter on both sides thereof" was sponsored by Mr. Lucas and given its first reading.

Mr. Schweizer than made the following motion: "I move that the statutory rule requiring ordinances and resolutions to be read on three separate and distinct days be dispensed with so that Ordinance No. 8-1941 may be given its second and third readings."
