MINUTES OF SPECIAL MEETING OF THE COUNCIL.

As per adjournment, the Council of the Village of Centerville, in the County of Montgomery and State of Ohio, met in special session on Tuesday evening, June 25, 1940, at 8 o'clock in the Council Chamber.

Present: Messrs. Walter H. Woods, Joseph S. Lucas, Grafton E. Shawen, Lloyd Hibberd and Franklin Zimmerman with Mayor Emory W. Bradstreet presiding. Mr. Thomas J. Davis was absent.

Messrs. William Fox and Richard Turner, of the Boarde of Public Affairs, and Leo Wall, Village Engineer, were also present.

Mr. Lucas thereupon introduced the following resolution and moved its adoption:

BE IT RESOLVED, that the Village Engineer in cooperation with the Board of Trustees of Public Affairs be and he hereby is authorized and directed to make all necessary adjustments in water service connections on South Main Street required by the improvement of said Main Street in cooperation with the Director of Highways of the State of Ohio, the cost thereof to be borne by the Village as part of the cost of the improvement.

Said motion was seconded by Mr. Zimmerman and carried. A roll call was ordered, which resulted in five "ayes" being cast in favor of the motion. Those voting in the affirmative were Messrs. Woods, Lucas, Shawen, Hibberd and Zimmerman. Thereupon Mr. Zimmerman introduced the following resolu-

BE IT RESOLVED, that the Board of Trustees of Public Affairs be and it hereby is ordered and directed to carry all water service connections from the main to the curb along that portion of Main Street about to be improved in cooperation with the Director of Highways of the State of Ohio, at those places where service connections have not as yet been made by the property owners.

Said motion was seconded by Mr. Shawen and carried. A roll call was ordered, which resulted in five "ayes" being cast in favor of the motion. Those voting in the affirmative were Messrs. Woods, Lucas, Shawen, Hibberd and Zimmerman.

Mr. Hibberd then made the following Motion: "I move that the statutory rule requiring ordinances and resolutions to be read on three separate and distinct days, be dispensed with, so that the foregoing Resolution No. 8 - 1940 may be given its second and third readings." Mr. Woods thereupon introduced Resolution No. 9 - 1940, being a "Resolution adopting plans, proposing to cooperate, requesting State Highway Director to proceed and authorizing execution of plans for the improvement of S.H. 64, Section Centerville (part), Montgomery County, Ohio", which was given its first reading.

Mr. Lucas then made the following motion: "I move that the statutory rule requiring ordinances and resolutions to be read on three separate and distinct days, be dispensed with, so that the foregoing Resolution No. 9 - 1940 may be given its second and third readings." Said motion was seconded by Mr. Zimmerman and carried. A roll call was ordered, which resulted in five "ayes" being cast in favor of the motion. Those voting in the affirmative were Messrs. Woods, Lucas, Shawen, Hibberd and Zimmerman.

Said Resolution No. 9 - 1940 was then given its second and third readings.

The question being shall said Resolution No. 9 - 1940 pass? Mr. Lucas thereupon moved that said Resolution No. 9 -1940 be passed, which was seconded by Mr. Woods and carried. The Clerk thereupon read the certificate of the State Highway Director, wherein he records his decision to proceed with the improvement of that portion of State Highway No. 64, in the Village of Centerville, Montgomery County, Ohio.

BE IT RESOLVED, that the Village Solicitor be and he hereby is authorized to assist the Village Clerk in the preparation of the 1941 budget.

Said motion was seconded by Mr. Shawen and carried. A roll call was ordered, which resulted in five "ayes" being cast in favor of the motion. Those voting in the affirmative were Messrs. Woods, Lucas, Shawen, Hibberd and Zimmerman.

It was moved by Mr. Hibberd, seconded by Mr. Zimmerman and carried that the meeting adjourn. A roll call was ordered, which resulted in five "Ayes" being cast in favor of the motion.
