MINUTES OF ADJOURN MEETING OF THE COUNCIL.

The Council of the Village of Centerville, in the County of Montgomery and State of Ohio, met pursuant to adjournment on Monday evening, December 30, 1940 at 7:30 o'clock in the Council Chamber.

Present: Messrs. Walter H. Woods, Joseph S. Lucas, Thomas J. Davis, Grafton E. Shawen and Franklin Zimmerman with Mayor Emory W. Bradstreet presiding. Mr. Lloyd Hibberd did not respond to the roll call.

Mr. Davis thereupon introduced Resolution No. 14 - 1940

being "Resolution accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor.
