The rates for users outside the corporate limits of the Village of Centerville shall be the same as those charged residents in the Village of Centerville, except that an additional charge of Twenty Five per cent (25%) of the rates prevailing under this ordinance in said Village shall be added, to be paid by users outside the corporate limits of said Village of Centerville."
