MINUTES OF ORGANIZATION MEETING OF COUNCIL

The re-elected and newly elected members of the Council of the Village of Centerville, in the County of Montgomery and the State of Ohio, met in the Council Chamber on Thursday Morning, January 1, 1948 at 11:00 O'clock for the purpose of organization. Present: Messrs. Robert J. Schweizer, W. H. Puterbaugh, Don Schell, Robert H. Fox, and E.C. Crane.

The Mayor opened the meeting with prayer.
