Discussions followed concerning improvement of East ridgeway through Weidnerplat, the construction of steps to residences on Weller Ave. and the proposed sewerage system.

Many people interested in the sewerage system were present . After a lengthy discussion the Council adopted the following resolution. It was moved by Mr. Fox, seconded by Mr.

Crane and carried that Resolution No. 11-1948, being"That the Council of the Village of Centerville go on record as being unanimously opposed to the location of a municipal sewage treatment plant within the corporate limits of the Village and favors the establishment of a Sanitary Conservancy District to include other adjoining areas for the collection and treatment of sewage from the entire district". A roll call was ordered which resulted

in 6 ayes in favor of the motion.
