The Mayor directed Mr. Wall to draw up specifications for the finish cost to be placed on East Ridgeway.

Then Mr. Presbaugh introduced Ord.2-87, being, "AN Ordiance to make appropriations for Current Expenses and other Expenditures of the Village of Centerville, State of Ohio, during the fiscal year ending December 31, 1957"

Mr. Dutcher made the following motion, "I move the statutory rule for Resolutions and Ordinances to be read on three separate and distinct days be dispensed with so that Ord.2-57 may be given its second and third readings", seconded by Mr. Arnold and carried. Then Mr. Dutcher introduced Ord.3-57, being, "An Ordisace to provide for the employment of and to fix the salary of the Village Marshall (\$4700. plus \$350.uniform allowance). Mr. Presbaugh made the following motion, "I move the statutory rule for reading Resolutions and Ordinances on three separate and distinct days be dispensed with so that Ord. 3-57 may be given its second and third readings," seconded by Mr. Arnold and carried. A roll call resulted in 5 ayes in favor of the motion.Ord.3-57 was given its second and third readings. The question being, shall Ord.3-57 be passed?

It was moved by Mr. Neubauer, seconded by Mr. Poff and carried.

The voting resulted as follows: Neubauer, aye; Poff, aye; Presbaugh, aye; Arnold.aye; Dutcher, aye; Billett, absent.

Mr. Wall was to contact Mr. Paxson concerning W. Franklin St. Discussion followed to reduce the performance bond of Mr. Zengel and to establish a new Ord. to raise Bldg. Permit fees so as to cover expenses of inspection, etc.
