Mr. Woolpert then gave a history of the developments of Centerville's Sewerage problem. He suggested that the Council supplement the existing contract dated March 25, 1946, and the council should form a Public Relations Committee to inform the public and to cope with the opposition outside of the Corporate limits.

It was moved by Mr. Dutcher, seconded by Mr. Presbaugh that Mr. Lynn be directed to supplement the existing contract with Ralph L. Woolpert Co. dated March 25. 1946, and the Ralph L. Woolpert Co. to be the consulting engineer. A roll call was ordered which resulted in 5 ayes in favor of the motion.

It was moved by Mr. Arnold, seconded by Mr. Dutcher, that the Council pay the State #350. for black top from the Sheehan rd. to the 24' pavement in Centerville, to be placed on the burms. A toll call was ordered which resulted in 4 ayes in favor of the motion. Mr. Poff was absent for the voting. The meeting adjourned.

Regular Meeting

The Council of the Village of Centerville, County of Montgomery and the State of Ohio met in regular session with Mayor Jackson presiding, September 9, 1957. The Mayor's report of Fines, Forfeitures and Costs amounting to \$631., State Court cases amounting to \$244.75, Building permits amounting to \$96., showing that the same had been paid in the Village treasury was submitted. It was moved by Mr. Presbugh, seconde by Mr. Poff and carried that the report be accepted and placed on file. A roll call was ordered which resulted in 6 ayes in favor of the motion.

Mr. Atkinson and Mr. Neal representing the Dayton Power & Light Co. asked the Council to change the position and location of a 4000 lumen light requested in park on XXXX West Ridgeway. A written treasurer's report was submitted. It was moved by Mr. Arnold, seconded by Mr. Neubauer and carried that it be accepted. A roll call resulted in 6 ayes in favor of the motion.

A repert followed by the Street committee. The Mayor was to contact the property owners on Sheldon and Lyons drive in reference to their desire of having curb and gutter. It was decided to get all streets patched before winter. Mr. Wall was to inspect streets to have ditches leveled so weeds can

be mowed next summer. It was decided to call a special meeting for Sept. 16 to discuss further the acceptance of the State's offer on West Franklin.

Mr. Arnold gave his report of the meeting with the Montgomery Co. Budget commission. He stated that the letter sent
with the estimated budget showing why the expenditures were more
than the receipts, had its beneficial effect. He stated also
that it was a pleasant experience and the reason why Centerville
does not get more is because the Village stands the expense of
Street lighting which should be borne by the taxpayers. It
was moved by Mr. Arnold, seconded by Mr. Presbaugh KANXXXXXXXXX
that the Village have an Ordinance drawn to charge the Public
Street Lighting on the Village tax duplicate. Discussion followed.
It was decided that more information was necessary and authorized
Mr. Lynn to get that data. Then Mr. Arnold withdrew his motion,
likewise. Mr. Presbaugh did also.

The Mayor theninformed the Council of shooting of guns at the quarry, the purchase of a cabinet for blue prints, the necessity of keeping all performance bonds in the Mayor's office, and he had an application for a variance in Zoning.

The Police commission was to investigate the shooting at the quarry and means of preventing same. The Council agreed to the purchasing of the cabinet and keeping of bonds in the Mayor's office. As to the variance in zoning, this particular place, Bradstreet Rd. at R. 48 and Moonlite Inn, have been discussed befor and the party or parties interested should make application to the Playming Board of appeals and set a date for Public Hearing.

The Council agreed that an Ordinance to increase the street bond for digging be raised from \$100. to \$250. and account for any longitudinal digging to be added to the \$250. The meeting adjourned.
