Regular meeting of Council

The Council of the Village of Centerville, County of Montgomery and the State of Ohio, met in regular session, Monday April 5, 1954, 7:30 P.M. with Mayor Kelsey presiding. Present: F.C. Lyons, John Anthony, Don Schell, James Presbaugh, Kenneth Poff. Visitors were Mr. W.W. Bentley and C.F. Carter.

It was moved by Mr. Poff, seconded by Mr. Presbaugh and carried unanimously that as soon as bill is received from the E.L. Kenney Tree Surgery, that it be paid. V.53 E.L. Kenney Tree Surgery-Tree removal 105.00

St. Maint.(G) Fund V.42 The Dayton Power & Light-March Traffic light 6.00 1611.89 The Mayor's report of Fines, Forfeitures and Costs amounting to \$291.50, State Cases amounting to \$30. and Building Permits amounting to \$71., showing that the same had been paid in the Village treasury, was submitted. It was moved by Mr. Presbaugh seconded by Mr. Anthony and carried unanimously that the report be accepted and placed on file. A roll call was ordered which resulted in 5 ayes in favor of the motion. The Council authorized the clerk to return the Bond by Ord. 13-1953 to J. Mason McClure because his obligation of repairing street was fulfilled. The Council withheld the payment further of bond on East Drive until investigated/and approved by Street Committee.

The Council was asked to consider the rezoning to permit Hiles residence to be used as a Funeral Home. After discussion it was recommended that adjoining property owners be contacted, and ask the planning Board what facilities are available for parking.

Discussion followed concerning the curbing of South side of West Franklin from R.48 to the School. Some thought the street in its present state would have to cut down before such a project could be done properly. The State engineer should be contacted before anything is done.

It was suggested that the makefacturer of the present traffic light be contacted so a switch could be placed on the light to change the light all red in case of emergency.

Mr. Clyde Long conveyed his appreciation for the fireplug and street light, which were installed in his vicinity.

The agreement for Fire Protection between the Village and Washington Township was tabled.

It was the suggestion of Mr. Lyons that some member or all the Council meet with the Board of Education to solve existing questions concerning Virginia Avenue.

The meeting adjourned.
