The Mayor's report of Fines, Forfeitures, and Costs amounting to \$289.00; billing permits amounting to \$130.00; and State Court Cases amounting to \$150.00; showing that the same hadebeen paid in the Village Treasury was submitted. It was moved by Mr. Presbaugh, seconded by Mr. Anthony and carried that the Mayor's report be accepted and placed on file. A roll call resulted in five ayes in favor of the motion.

Mr. Lynn read a letter from the Dayton Law Library Ass. showing that the Village owes the association \$463.69 accumulated from Feb. 9, 1951. It was moved by Mr. Presbaugh, seconded by Mr. Schell and carried that the Mayor take \$50.00 per month out of fines, until the \$463.69 bill to the Dayton Law Library has been paid. A roll call was ordered which resulted in five ayes in favor of the motion.

Mr. Lynn was to call the Dayton Power Light Co. concerning the ordinance for raising the gas rate in the Village of Centerville.

The Planning Board reccommend that \$5.00 be paided for inspection of lay-out of house before construction is started. The fee to be paid out of the General Fund. This is to be brought in as a regular bill.

It was moved by Mr. Schell, seconded by Mr. Poff and carried that the resolution to authorize money for needed street signs in the Village of Centerville, as designated in March 10, 1952 meeting by the Street Committee be granted. A roll call resulted in five ayes in favor of the motion.

The question of a fire plug in front of Mr. Clyde Long's residence was mentioned but no action was taken.

Then Mr. Presbaugh introduces Ord. 7-1953, "Being an Ordinance to control the casting or dumping of unwholesome or foreign material into and upon any street, sidewalk or public way within the Village of Center-ville". Mr. Poff made the following motion: "I move the statutory rule requiring for Ordinances and Resolutions to be read on three distinct and separte days be dispensed with so Ordinance 7-1953 may be given its second and third reading", seconded by Mr. Schell and carried. A roll call was ordered which resulted in five ayes in favor of the motion. Said Ordinance 7-1953 was given its second and third readings.

The question being, Shall said Ord. 7-1953 be passed? It was moved by Mr. Lyons, seconded by Mr. Schell and carried that Ord. 7-1953 be passed. A roll call was ordered which resulted in five ages in favor of the motion.

Thereupon Mr. Schell introduces Ord. 821953, "Being an Ordinance suthorizing the inclusion of the Village of Centerville, an incorporated municipality, in a sewer district established by the Board of County Commissioners, Montgomery County, Ohio." Mr. Presbaugh made the following motion:"I move the statutory rule for requiring Ordinances and Resolutions to be read on three distinct and separate days be dispensed with so Ord. 8-1953 may be given its second and third readings," seconded by Mr. Lyons and carried. A roll call was ordered which in four ayes in favor of the motion and one may by Mr. Poff against the motion. Said Ordinance 8-1953 was given its second and third readings.

The question being, Shall said Ord. 8-1953 be passed? It was moved by Mr. Lyons, becomded by Mr. Schell and carried that Ord. 8-1953 be passed. A roll call was ordered which resulted in four ayes in favor of the motion and one may by Mr. Poff against the motion.

Mr. Cowden reported it would cost approximately \$100.00 to patch West Ridgeway, to prime and reseal same from Route 48 to Hampton; the cost would be \$841.60, making a total of \$941.60. Other bids were as follows: Maple Ave. \$163.20; Lakeview Dr. \$480.00; Linden Ave. \$1440.00. This makes a total \$2083.20 in the Zengel Platt. It was moved by Mr. Schell, seconded by Mr. Presbaugh and carried that the bid on West Ridgeway from Route 48 to Hampton Rd., amounting to \$941.60 be accepted. A roll call was ordered which resulted in four ayes in favor of the motion and one may against the motion by Mr. Lyons. The motion carried.

Mr. Lee Ware's letter was read to the Council and Board of Public Affairs. The letter was discussed, all members taking part in the discussion. However, no desision was reached. Mr. Lyons made the following comment that a proposed letter was discussed in a meeting when Mr. Ware was a visitor. However, this letter was not sent to Mr. Ware because the motion to send the letter was not passed by the Council. It was moved by Mr. Schell, seconded by Mr. Poff and carried that the meeting adjourned. The meeting adjourned at 11:30 P.M.
