It was moved by Mr. Lyons, seconded by Mr. Presbaugh and carried that Mr. Poff be authorized to act as Pres. of Council. A roll call resulted in 6 ayes in favor of the motion.

Then the Mayor elect Mr. Kelsey was given the oath of office by Mayor Bradstreet.

It was moved by Mr. Schweizer, seconded by Mr. Propeter and carried that the Council adjourn sine die. A roll call resulted with 5 ayes in favor of the motion.

Mayor Kelsey then became presiding officer.

It was moved by Mr. Lyons, seconded by Mr. Schell and carried that a vote of gratitude be given to ex-mayor Bradstreet for his loyalty and devotion to his office as Mayor of Centerville for the last 12 years. A roll ^{call} resulted in 6 eyes in favor of the motion.

The following committees were appointed by the Mayor
Village record committee-Lyons, Schell, Anthony

Planning committee- John Anthony

Bight committee- Schell, Poff, Anthony

Street committee- Lyons, Tippy, Presbaugh

It was moved by Mr. Schell, seconded by Mr. Poff and carried that the above appointments be accepted. A roll call resulted in 6 eyes in favor of the motion.

Discussion followed concerning the appointment of Village Marshal. After the discussion, it was moved by Mr. Presbaugh, seconded by Mr. Anthony that James R. Smith be appointed as the Marshal of Centerville, the salary to be equivalent to the Deputy Marshalls and Marshal's salaries, and he is to assume all duties as Marshal. A roll call was ordered which resulted in 6 eyes in favor of the motion.

It was moved by Mr. Schell, seconded by Mr. Bradstreet and carried that the out-going councilmen, Mr. Schweizer, Mr. Crane and Mr. Propheter be given a vote of thanks for their work while on the council.

It was moved by Mr. Schell, seconded by Mr. Poff and carried that all regular meetings of Council will be held the second Monday of each month at 7:30 P.M. A roll call resulted in 6 eyes in favor of the motion.

The Mayor, by the council's request, was to check local Attorneys to see if they would serve as solitor to the Village.

It was moved by Mr. Poff that the meeting adjourn.
