Mr. Galloway, Mr. Maxwell, Mrs Lowry and Jack Puterbaugh of the planning Board presented to the Council the plans for development of Mr. Galloway's property. A discussion followed in reference td the streets, septic tank permits, etc. The Council decided to table the matter until the next meeting.

Mr. Roger Cowden was present to explain how a new street should be made. He suggested that the Council should have at least the County minimum Standards. He stated he would get us these standards and also curb and gutter specifications.

Threupon Mr. Schell introduced Ord. No. 3- 1952, being <sup>Na 3A.</sup> " An ordinance fixing the yearly salary of the Village Marshall at \$3040., Paid in monthly installments", and the Deputy Marshall's salary at \$1.00 per year".

Mr. Presbaugh made the following motiom, "I move the statutory rule requiring Ordinances and Resolutions to be read on three distinct and separate days be dispensed withn so that Ord. 3-1952 may be given its second and third readings," seconded by Mr. Anthony and carried. A roll call resulted in 5 ayes in favor of the motion.

The question being, shall said Ord. 3-1952 be passed? <sup>3A-</sup> It was moved by Mr. Poff seconded by Mr. Anthony and carried that Ord. 3-1952 be passed. A roll call resulted in 5 ayes in <sup>3A</sup> favor of the motion.

The Mayor read a card from the family of Estella Schell acknowledging the Council's sympathy during their bereavement.

It was moved by Mr. Anthony that the meeting adjourn.
