The Council of the Village of Centerville, County of Montgomery and the State of Ohio, met in regular session with Mayor James Kelsey presiding, 7:30 P.M. March 24, 1952. Present: Kenneth Poff, John Anthony, James Presbaugh and Donn Tippy.

The minutes of the March 10, meeting were read and approved.

It was moved by Mr. Tippy, seconded by Mr. Anthony and carried that the Council accept the Washington Twp. Proposal to furnish room for council meetings, including utilities for the sum of \$150.00. A roll call was ordered which resulted in 4 ayes in favor of the motion.

Mr. Cowden gave the council estimates for the streets Bradstreet, Maple, W. Ridgeway, Hampton and Linden.

It Was moved by Mr. Poff seconded by Mr. Tippy and carried that the H.S. Shop boys make the bulletin board for the Village at a cost of \$25.00. A roll call resulted in 4 ayes in favor of the motion.

Thereupon, Mr. Tippy introduced Ord. No.4-1952, being "An Ordinance for the purchase and erection of certain traffic "stop" signs within the Village. Be it ordained by the Council of the Village of Centerville, State of Ohio:

Section I . That traffic "stop" signs of the regulation type approved by the Director of Highways, State of Ohio, shall be erected for the purpose of regulating vehicular traffic under the supervision of the Village Marshall at the following street intersections and junctions of streets:(1) W. Ridgeway & Main, (2) E. Ridgeway & Main, (3)Bradstreet Rd. & Main, (4)W. Ridgeway & Normandy Lane, (5)Hampton Rd. & Franklin, (6)Maple Ave. & Franklin, (7)East Dr. & Franklin, (8)Weller Ave. & Main, (9) Martha Ave & Main.

Section II. That the expenditure of \$60. for the purchase of said traffic signs is hereby authorized, and the expenditure of the further sum necessary to effect the erection of such signs at the designated intersections and junctions.

Section III. That all Ordinances or parts of Ordinances inconsistent herewith shall be repealed and this Ordinance shall take effect from and after the 24th day of April, 1952."

Mr. Presbaugh made the following motion," I move the statutory rule requiring Ordinances and Resolutions to be read on three distinct and separate days be dispensed with so that Ord. 4-1952 may be given its second and third readings," seconded by Mr. Anthony and carried. A roll call resulted in 4 ayes in favor of the motion.

Said Ord.No.4-1952 was given its second and third readings. The Question being, shall said Ord. No.4-1952 be passed? It was moved by Mr. Poff, seconded by Mr. Presbaugh and carried that Ord. No.4-1952 be passed. A roll call was ordered which resulted in 4 ayes in favor of the motion.

Mr. Zengel was present to ask the Council to reconsider or study and extend the business district of the Village. No action was taken.

Mr. Presbaugh presented a financial report of the Village finances to date and the next report would be May 12.

The meeting was adjourned.
