The Council of the Village of Centerville, County of Montgomery and the State of Ohio, met in regular session with Mayor James Kelsey presiding, 7:30 P.M. June 9, 1952. Present: Kenneth Poff, F.C. Lyons, John Anthony, Don Schell, James Presbaugh, James Lynn. The minutes of the May 12, 1952 meeting were read and appromed. It was moved by Mr. Schell, seconded by Mr. Poff and carried that the following bills be approved for payment.

No.5-1952 may be given its second and third readings,"seconded by Mr. Anthony and carried. A roll call resulted in 5 ayes in favor of the motion. Said Ord. No.5-1952 was given its second and third readings. The question being, shall said Ord. No.5-1952 be passed? It was moved by Mr. Schell, second by Mr. Lyons and carried that Ord. No. 5-1952 be passed. A roll call resulted in 5 ayes in favor of the motion.

Then Mr. Schell introduced Ord.No.6-1952, being 3" An Ordinance to regulate and establish standard specifications for the construction of streets and roadways within the said Village", Mr. Presbaugh made the following motion," I move the statutory rule requiring Ordinances and Resolutions to be read on three distinct and separate days be dispensed with so that Ord. No. 6-1952 may be given its second and third readings," seconded by Mr. Poff and carried. A roll call resulted in 5 ayes in favor of the motion.

Said Ord. No.6-1952 was given its second and third readings. The question being, shall said Ord. No. 6-1952 be passed? It was moved by Mr. Anthony, seconded by Mr. Schell and carried that Ord. N.6-1952 be passed. A roll call resulted in 5 ayes in favor of the motion.

Mr. Poff introduced Ord. No.7-1952, being"An Ordinance to accept a certain application for annexation of territory", **xazamdadxby** Mr. Anthony Made the following motion,"I move that the statutory rule requiring Ordinances and Resolutions to be read on three distinct and separate days be dispensed with so that Ord.No.7-1952 may be given its second and third readings," seconded by Mr. Presbaugh and carried.A roll call resulted in 5 ayes in favor of the motion.

Said Ord. No.7-1952 was given its second and third readings.

The question being, shall said Ord. NO.7-1952 be passed? It was moved by Mr. Poff, seconded by Mr. Anthony and carried that Ord. No.7-1952 be passed. A roll called resulted in 5 ayes in favor of the motiom.

The Council decide that "No Swimming " signs be posted . at the quarry.

It was moved by Mr. Lyons, seconded by Mr. Schell and

carried that, the Mayor shall be authorized to obtain the services of Ralph L. Woolpert Co. for the purpose of an Engineering Survey within the corporate limits of Centerville to determine an accurate estimate cost of installing the lateral sewer lines using per front footage assessment method, said lateral lines to be connected in conjunction with the Holes Creek Sewer District. It is authorized that \$200.00 be expended to make test holes so this estimate cost can be made." A roll call resulted in 5 ayes in favor of the motion.

Mr. Bair was present and asked the Council to furnish onehalf the cost of the tile in front of his property, so that the ditch in front of his home can be closed. The approximate cost for the Village would be \$27.50. Mr. Poff moved the Council pay for one-half cost of the tile, seconded by Mr. Anthony. The roll call resulted as follows: Mr. Poff, aye;Mr. Anthony,aye; Mr.Lyons, nay:Mr. Presbaugh,nay;Mr. Schell,not voting. The tie was broken by the Mayor's aye vote.

Mr. Shawen would like the Council to have the ditch opened at East Frank lin where the sidewalk ends. The alley drainage at the rear of Mr. Getter's resisence was also mentioned. No decisions were made.

Report from the Board of Public Affairs by Mr. Millen stated the plant would increase its water supply the coming week because of redent changes at the plant.
