The Street committee reported that North Maple Street had deep ditches on both sides and proper base lacking, Also West Ridgeway was washed where water lines had been laid.

It was moved by Mr. Lyons, seconded by Mr. Poff that the check of Mr. Gorman be deposited in the Village fund because of the default of the conditions in the contract of the bond. A roll call resulted in 6 ayes in favor of the motion.

The Dog problem was brought before the Gouncil. The Marshall was ordered to collect the strays and call the Dog Pound.

It was moved by Mr. Poff, Seconded by Mr. Schell and carried that the weeds in the Village be mowed. Mr. Pease to be contacted for the project. A roll call resulted in 6 ayes in favor of the motion.

The Clerk presented the Budget, as compiled by the Budget Committee, to the Council for approval. It was moved by Mr. Tippy, seconded by Mr. Schell and carried that the proposed budget for 1953 be accepted. A roll call resulted in 6 ayes in favor of the motion.
