

MINUTES OF REGULAR MEETING

The Council of the Village of Centerville, County of Montgomery and the State of Ohio, met as adjourned April 9 to meet April 23, 1951 to continue business, Present: Don Schell, John Anthony E.C. Crane, and R.C. Propheter. Mr. Schweizer and Mr. Lyons were absent.

It was moved by Mr. Anthony, seconded by Mr. Crane and carried that a 12" tile be placed under the road near Kenneth Poff's Property on East Franklin. A roll call resulted in 4 eyes in favor of the motion.
