**A RESOLUTION ADOPTING THE AMERICANS WITH  
DISABILITIES ACT (ADA) TRANSITION PLAN FOR THE CITY  
OF CENTERVILLE.**

WHEREAS, the Americans with Disabilities Act (the “ADA”), adopted in 1990, and the Americans with Disabilities Act Amendments Act (the “ADAAA”), adopted in 2009, prohibits discrimination against individuals on the basis of disability; ; and

WHEREAS, the City of Centerville must comply with Title II of the ADA as it specifically applies to public service agencies; and

WHEREAS, the City of Centerville has conducted a self-evaluation of its services, programs, activities and facilities pursuant to Title II of the ADA on City-owned properties and within its rights-of-way; and

WHEREAS, the ADA through the Code of Federal Regulations, Title 28, mandates that public entities with more than 50 persons must establish an ADA Transition Plan; and

WHEREAS, the proposed ADA Transition Plan for the City of Centerville was properly made available to individuals with disabilities or organizations representing individuals with disabilities, to solicit comments from the general public for a period of thirty (30) days beginning August 10, 2020, and ending September 9, 2020; and the Transition Plan was made available for public inspection; and

WHEREAS, an approved and adopted ADA Transition Plan assists in ensuring compliance with the ADA’s accessibility mandates in order to secure federal funding for future roadway improvement projects.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE  
HEREBY RESOLVES:

Section 1. The City of Centerville hereby adopts the City of Centerville  
Americans with Disabilities Act Transition Plan, attached hereto as Exhibit A.

Section 2. The City of Centerville intends to implement, execute, and  
routinely update this ADA Transition Plan to ensure compliance with Title II of the  
ADA and the ADAAA.

Section 3. This Resolution shall become effective at the earliest date  
allowed by law.
