A RESOLUTION AUTHORIZING THE COVID-19 NON-PROFIT
RELIEF PROGRAM FOR THE CITY OF CENTERVILLE.

WHEREAS, on March 13, 2020, President Donald Trump declared a National Emergency concerning the Novel Coronavirus Disease (COVID-19) outbreak; and

WHEREAS, in Executive Order 2020-01D, Ohio Governor Mike DeWine declared a state of emergency for the entire State to protect the well-being of the citizens of Ohio from the dangerous effects of COVID-19 and to assist in protecting the lives, safety, and health of the citizens of Ohio; and

WHEREAS, the City of Centerville has declared a State of Emergency related to COVID-19; and

WHEREAS, the City has a business relief program in place to assist businesses directly affected by the COVID-19 pandemic; and

WHEREAS, the City desires to now extend the grant program to assist non-profits in the City to address the negative financial effects of the COVID-19 pandemic with a program intended to help with expenses directly resulting from an increase demand on non-profits' resources to assist with the direct costs of providing services necessary to respond to the COVID-19 pandemic; and

WHEREAS, the State adopted HB 481, which made funds available for such programs through the Coronavirus Relief Distribution Fund; and

WHEREAS, the City has a relationship with the Centerville Community Improvement Corporation (CCIC), which administers grant programs for the City.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE
HEREBY RESOLVES:

Section 1. The City Council hereby directs City Staff to create a grant program for City non-profits that are impacted by COVID-19, to be funded by the HB 481 Coronavirus Relief Distribution Fund and administered by the Centerville Community Improvement Corporation.

Section 2. Attached hereto and incorporated herein are the terms and conditions for the program.

Section 3. This Resolution is to take effect at the earliest date allowed by law.

CENTERVILLE COVID-19 NON-PROFIT RELIEF PROGRAM

In an effort to provide additional resources to non-profit organizations providing vital services necessary to address the COVID-19 pandemic, the City of Centerville authorized the Non-profit Relief Program. This program is intended to assist non-profit organizations with direct costs of responding to the COVID-19 pandemic.

Eligible Recipients:

- Principal place of business and location(s) where services are rendered must be in the City of Centerville
- Must be 501(c)(3) tax exempt organization registered with the State of Ohio and Internal Revenue Service (IRS)
- Must be a charitable organization registered with State of Ohio Attorney General's Office
- Must not use CARES Act funding in place of or instead of local, state, federal, or other funds already designated for that expense or activity
- Is currently in compliance with all U.S. Treasury Department regulations, including those applicable to its 501(c)(3) status
- Has been in operation and provided essential social and family services since at least January 2019
- Has prior experience in successfully managing federal, state or local financial assistance and/or grant funding
- Must demonstrate and document that they incurred increased costs due to the public health emergency from March 15, 2020 to October 31, 2020
- Must be registered as a 501(c)(3) with the Ohio Secretary of State and in good standing

Program Priority:

- Organizations providing social and family services with a focus on access to food, domestic violence, supportive services, substance abuse, services benefiting senior citizens, mental health and foreclosure prevention

Application Process and Review:

The City of Centerville will accept and review applications for the Non-Profit Relief Program. Applications will be evaluated on a first come-first serve basis. In the event requests exceed available funds, priority will be given to applicants based upon the following criteria: need for assistance, program priority and overall impact of the grant.

Ineligible Expenses:

- Revenue replacement
- Construction costs (supplies and materials are eligible)
- Overhead costs
- Costs for political activities, including lobbying

Form of Assistance Available:

- Grants up to \$5,000 for reimbursement of eligible expenses related to services necessary to address the COVID-19 pandemic. Documentation of eligible expenses must be submitted with grant application.

Please note, the COVID-19 Non-profit Relief Program is not an entitlement program, and as such, funding through this program is not guaranteed.
