- A. Medication Safety Ms. Trent Smith, representing Goodwill/Easter Seals, presented information about the upcoming DEA Drug Takeback Day on Saturday, October 24, 2020, taking place in the front parking lot of the Centerville Police Department, 155 West Spring Valley, from 10 a.m. until 2 p.m. She spoke about safe medication storage practices, noting that Goodwill has medication lock boxes available upon request. - B. Chief Matt Brown presented the following annual Police Department Awards:
