certified copy of the resolution to withdraw. The presentation of the resolution to withdraw shall not relieve the withdrawing party of its obligations to contribute its share of the cost for the year in which the withdrawal occurs, nor shall it withdraw its area from the study area of the Miami Valley Regional Planning Commission during this year of withdrawal.

BE IT FURTHER RESOLVED THAT: These terms of maintenance and cooperation shall take effect immediately upon their adoption and certification by the legislative body of said city, village or county.

BE IT FURTHER RESOLVED THAT: The Director of the Miami Valley Regional Planning Commission shall, upon receipt of the duly adopted and certified resolution, thereafter include said political subdivision as a full member in the Miami Valley Regional Planning Commission with all rights and privileges thereto.

BE IT FURTHER RESOLVED THAT: The Village of Centerville shall not be bound by this Agreement if there is not sufficient participation from the area's political subdivisions to make the formation of the Miami Valley Planning Commission feasible.

RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

The Council of the Village of Centerville, Montgomery County Ohio, met in regular session the 7th day of September, 1965, at the office of Village Hall with the following members present: Charles Taylor, Clarence Stingley, Richard Knierer, Howard Griest, John Theiss, Kenneth McClellan.

Mr. Taylor moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Village of Centerville, Montgomery County, Ohio; therefore, be it

RESOLVED, By the Council of the Village of Centerville, Montgomery County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy an additional tax in excess of the ten mill limitation for the benefit of Village of Centerville for the purpose of Police Department Maintenance and Operation at a rate not exceeding 1 mill for each one dollar of valuation, which amounts to 10 cents for each one hundred dollars of valuation for 5 years and, be it further

RESOLVED, That said levy be placed upon the tax lists of the current tax year in compliance with the provisions of Sec. 5705.34, current tax duplicate starting with first half collection, if the majority of the electors voting thereon vote in favor thereof; and, be it further

RESOLVED, That the Clerk of this Council of the Village of Centerville be and he is hereby directed to certify a copy of this Resolution to the Board of Elections, Montgomery County, Ohio, prior to the Fifteenth day of September 1965, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.
