RESOLUTION DESIGNATING PUBLIC DEPOSITORY AND AWARDING PUBLIC MONIES PURSUANT TO THE UNIFORM DEPOSITORY ACT OF OHIO, BY THE VILLAGE OF CENTERVILLE, OHIO.

WHEREAS, the Council of the Village of Centerville desires to designate a depository for the holding of active deposits of the Village for the two (2) year period beginning at the expiration of the current depository agreement; and

WHEREAS, it is estimated by the Council of the Village of Centerville that the probable amount of public monies to be deposited at the beginning of the period of designation will be \$17,000.00 and that the probable maximum amount subject to deposit at any time during such period will be \$80,000.00; and

WHEREAS, a written application has been received from the Centerville Branch of the First National Bank of Miamisburg; and

WHEREAS, Section 135.06 of the Ohio Revised Code requires that any institution mentioned in Section 135.04 of the Ohio Revised Code which has an office located within the territorial limits of Centerville is eligible to become a public depository of the active public monies of Centerville; and

WHEREAS, the Centerville Branch of the First National Bank of Miamisburg is within the territorial limits of Centerville;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Centerville as follows:

That the deposit of the monies of the Village of Centerville, Ohio, be awarded in the case of active deposits to the Centerville Branch of the First National Bank of Miamisburg, which bank shall become the depository for such monies of the Village for a period of two (2) years from the end of the current depository agreement, upon duly executing and delivering a written memorandum or agreement for the deposit of public funds and duly pledging and depositing eligible securities for the repayment of all public monies to be deposited in the public depository, in accordance with Ohio Revised Code Sections 135.10, 135.13, 135.14, 135.15 and 135.16

RESOLUTION NUMBER 6-1965 VILLAGE OF CENTERVILLE, OHIO

A RESOLUTION TRANSFERRING FUNDS WITHIN THE GENERAL FUND AND WITHIN THE STREET MAINTENANCE AND REPAIR FUND

WHEREAS, it is necessary for the following funds to be transferred from funds to provide for additional Architect Fees, Engineering Services, Solicitor Service, Legal and Advertising Costs, Deductions by the State Auditor, Dispatching, Gasoline, Street Lighting costs (due to charge made by auditor), Insurance, Equipment Purchases and whereas, these funds are available for transfer within the General Fund of the Village of Centerville, County of Montgomery and State of Ohio;

Whereas it is necessary to transfer \$11.00 from A-2 Mayor and \$250.00 from C-3 Clerical to A-4 Engineer, and \$220.00 from B-1 Chief and \$55.00 from B-9 Tires to A-5 Solicitor; and \$245.00 from C-10 Other and \$29.00 from B-8 Miscellaneous Supplies to A-7 Deductions by State Auditor; and \$968.00 from B-6 Cruiser Repair and \$194.16 from B-12 New Cruiser and Equipment and \$157.00 from A-3 Clerk-Treasurer to A-6 Legal Advertising in the amount of \$1054.09 and to B-4 Gasoline in the amount of \$265.07; and transferring \$3561.23 from B-2 Police and \$90.00 from B-5 Uniforms to B-3 Dispatching; and to transfer \$181.43 from C-2 Planning Board and \$14.26 from C-7 Phones to C-5 Insurance in the amount of \$106.44 and to C-9 Architect in the amount of \$89.25; and transferring \$146.00 from A-1 Council and \$112.50 from C-6 Supplies to C-8 Equipment Purchases, and hereby transferring \$507.69 from B-7 Cruiser Oil & Lube and \$1219.73 from B-10 PERS and Hospital Care and \$187.69 from B-11 Other and \$560.00 from C-1 Rents and \$1253.41 from C-11 Street Resurfacing to C-4 Street Lighting.

WHEREAS it is necessary for the following funds to be transferred from funds within the Street Maintenance and Repair Fund for necessary payment to part time employees and for the purchase of miscellaneous supplies and for the purchasing of street signs and the payments of street lights.

Whereas it is necessary to transfer \$502.00 from H-8 Major Equipment Purchases to H-2 Employees Part time and to transfer \$332.00 from H-8 Major Purchases to H-5 Supplies of the Street Maintenance Fund and to Transfer \$800.00 from H-3 Salt to H-9 Traffic Signs and Lights.

NOW THEREFORE be it resolved by the Council of the Village of Centerville, State of Ohio that the above funds are available and transfer will be made.
