Those in attendance agreed that joint Meetings be held approximately two times a year, perhaps on a Monday evening early in the month and that the location be varied.

Mr. Kenning reviewed roadway and traffic improvements proposed for the City of Centerville during 1984 and 1985: federal, state and local projects. Discussion followed relative to the traffic congestion problem in and around the High School before and after school hours. Correcting suggestions were offered by Members of the City Council and Members of the School Board. This problem will be further reviewed by both administrations. It was pointed out that students drive to school due to their involvement after school in sports and other activities; taking away this privilege would only force parents to provide this necessary transportation.

The open lunch policy at the High School was also discussed briefly. Sentiment in the Community supports the open lunch policy.

Intangible Personal Property Taxes received by the school district were outlined by the School Board. Taxes should increase with future commercial and industrial development along proposed I-675 and other areas of the City. Various large construction projects recently approved by the City were outlined for School Board Members by Mr. Kenning and Mayor Heintz.

During discussion of future Board Issues, it was mutually agreed the City and the School District would not compete.

The School Busing Policy was outlined by the School Board for those in attendance. Centerville has a very excellent transportation system and has had for several years.



The possibility of a summer job core was briefly discussed. Mr. Kenning reviewed the City's summer help-seasonal employment program and the maintenance of City Property program begun in 1983. Specifications for the mowing program will be sent to the High School to invite interested students to bid in 1985.

The Latch-Key Project recently developed was briefly discussed. The effect of this program will only be realized through experience, it has been received in the Community very enthusiastically.


Subjects for the Adult School Program were discussed briefly. Mayor Heintz suggested that an evening course be offered teaching conversational German, considering the fact that Centerville has a Sister City in Western Germany.

Mr. Kenning reviewed the State Law causing cities to provide Civil Service Requirements for School District employees. Mayor Heintz pointed out the fact that the City has no Civil Service Commission due to requirements set forth in the City Charter. Clarification of this is being considered by the Charter Review Commission for the City of Centerville.
