Mr. Marshall explained the Committee which has been appointed to review open lunch and designated smoking areas at the Centerville High School. Their first Meeting has been scheduled.

Dr. Cleary gave a brief update on the Latchkey Program developed for students in the Centerville-Washington Township Area.

Mayor Heintz outlined plans for the construction of I-675, the construction schedule and the completion date not later than summer of 1986. The reconstruction of other roadways along with the construction of I-675 was also discussed. Potential growth areas in the City of Centerville were outlined.

Dr. Overly briefed the City on a Gala being planned to be held at the Centerville High School during January 1985. More information will be forthcoming.

Mr. Kenning asked that the City be kept abreast of achievements made by students and staff members in the Centerville school system so that proper recognition can be made by the City of Centerville.

Dr. Overly reviewed financial projections and needs of the Centerville school system for 1985 and 1986. Additional funds are being contemplated for 1985.

Enrollment trends were briefly outlined by Dr. Overly. There are currently just less than 7,000 students in the Centerville school system. This figure is 130 to 140 students less than 1983. Future trends were outlined both population and enrollment in the Centerville area.

Upon question of Mayor Heintz, Mr. Marshall advised that the Board of Education has retained ownership of Village South school in anticipation of its use again by the school system in future years.

Post-game activities in Centerville were discussed. Recommendations were as follows: Merchants should be encouraged to police their establishments more thoroughly when students begin to gather; Middle school students should be encouraged to accompany parents to and from games; Facilities are available in the High School if interested groups desire to organize an activity after a game. It was concluded that this is a matter of concern for parents and merchants and not the Centerville Board of Education.

Mr. Kenning suggested that piggyback projects be initiated, school construction projects be coordinated with City construction projects so that they may be lumped together when going to Bid. By so doing costs can be cut.

Mr. Kenning asked for pre-event information so that the City can plan for proper traffic control before and after the occasion. Discussion followed relative to the need for another access from the High School east to Cylo Road, across the Thomas Farm. Mr. Taylor suggested that this access be incorporated in the Centerville Thoroughfare Plan so that when development of this land occurs this roadway will be constructed.

Dr. Overly recognizes the need for the Adult School program to be geared more toward the Seniors in our Community. Mr. Marshall suggested that the standards be improved in Centerville's Adult School Program in the future.

Mr. Marshall advised of a contact from Washington Township that joint Meetings be held between the Board of Education, the City of Centerville and Washington Township. A tentative Meeting was scheduled for February, 1985, said Meeting to be coordinated by the City of Centerville.
