Mr. Davis provided an overview of anticipated improvements and priorities. The Architectural Preservation District will be maintained and complemented.

Mr. Engert spoke about the summer concert beer sales benefitting the Centerville High School baseball team and Jazz Band.

Mr. Engert informed about the Centerville-Washington History youth program workshops; signups are available on the website.

Mrs. Rau reported on recent MVCC announcements which included Point Broadband coming to the area to expand fiber to homes and businesses and that Miami Township is joining as a member.

Mrs. Rau discussed the Uptown mural process and approval through both the Board of Architectural Review and the Centerville Community Improvement Corporation.

Mr. Palcher praised Mrs. Bostdorff, Jim Collins, and the Arts Commission for their efforts regarding the summer entertainment programming.

Mr. Palcher praised Mr. Turnbull for his Streets Highways and Drainage Committee recruitment efforts.

Mr. Serr announced First Tier Suburbs Consortium will host a summit on September 15 at the Sinclair Ponitz Center, focusing on attracting and retaining work force talent in the region.

Mr. Lunsford reported that the Americana Festival will not include Arts and Craft vendors this year, but will include an expansion of the food truck vendors. Fireworks are scheduled for Sunday, July 4. Stadium seating will be available. The 5k run and parade will take place on Monday, July 5.

New Business

A. Application P-2021-0010: Record Plat

Applicant: Macy Downey, on behalf of Speedway

Location: 5495 Wilmington Pike

Mr. Yandrick presented the property description, application summary, and the standards of approval. The Planning Commission recommended 7-0 for approval of the application.

Mrs. Kenley made a motion for approval of the application, Mr. Lunsford seconded the motion, and it passed with 7 ayes.

B. Ordinance 06-21, An Emergency Ordinance To Repeal Ordinance Number 27-20 In Its Entirety And To Establish Class Titles, Pay Ranges, Grades, Rates Of Pay, And Regulations For Employees Of The City Of Centerville, Ohio.

Ms. McCormick explained the driver behind this emergency ordinance is the search for kitchen talent at Yankee Trace. The changes will make the City more competitive in the hiring process. The ordinance also includes a new IT position.

Mrs. Rau sponsored Ordinance 06-21 and moved for its approval. Mr. Serr seconded the motion, and it passed with 7 ayes.
