A RESOLUTION ACCEPTING THE BID SUBMITTED BY CENTURY EQUIPMENT, A JERRY PATE COMPANY OF HILLIARD, OHIO FOR THE PURCHASE OF ONE TORO GROUNDSMASTER 4700 MOWER AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, the City of Centerville received a bid through Sourcewell contract pricing, Sourcewell ID# 149180 and contract # 800816-STS515, a state bid consortium according to specifications prepared by the City, and

WHEREAS, pursuant to Ohio Revised Code Section 9.48, the City is allowed to participate in joint purchasing programs such as Sourcewell; and

WHEREAS, under the Sourcewell contracting pricing, Century Equipment, a Jerry Pate Company of Hilliard, Ohio, was the low and best bidder.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the bid submitted by Century Equipment, a Jerry Pate Company of Hilliard, Ohio, for the sale of one new Toro Groundsmaster 4700 Mower to the City Of Centerville for a bid price of \$87,301.16 is hereby accepted, a copy of which is attached hereto, incorporated herein, and Marked Exhibit "A".

Section 2. That the City Manager is hereby authorized to do all things necessary to execute a contract with Century Equipment, a Jerry Pate Company of Hilliard, Ohio, as stated above.

Section 3. This resolution shall become effective at the earliest date allowed by law.
