**ORDINANCE NO. 17-21  
CITY OF CENTERVILLE, OHIO**

Sponsored by Council Member Bill Serr on the 6<sup>th</sup> day of December, 2021.

**AN ORDINANCE TO REPEAL CHAPTER 284, SISTER CITY COMMITTEE, OF THE CENTERVILLE MUNICIPAL CODE.**

**WHEREAS**, the Sister City Committee for the City of Centerville was established August 6, 1973, by Resolution No. 28-73, and codified as Chapter 284 of the Centerville Municipal Code; and

**WHEREAS**, the Charter of the City of Centerville Section 9.01 gives City Council the authority by Ordinance to create all Boards and Commissions deemed necessary or desirable for the most efficient functioning of the Municipality; and

**WHEREAS**, the Charter of the City of Centerville, Section 9.02 gives the City Council the authority to abolish Boards and Commissions; and

**WHEREAS**, City Council has determined that there is not an active Sister City Committee and thus, no need to have such a committee; and


**WHEREAS**, City Council wishes to formally take action to abolish Chapter 284 of the Centerville Municipal Code.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That Chapter 284, Sister City Committee, of the Centerville Municipal Code shall be repealed in its entirety.

Section 2. This ordinance shall become effective from and after the earliest date allowed by law.
