RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE **CAPITAL** IMPROVEMENT COMMUNITY PARK, RECREATION/CONSERVATION **PROJECT PASS** THROUGH GRANT AGREEMENT WITH STATE OF OHIO DEPARTMENT OF NATURAL RESOURCES (ODNR) FOR **FUNDS** THE **STUBBS** GRANT OF FOR IMPROVEMENTS PROJECT.

WHEREAS, the City is desirous to make improvements consisting of renovations and upgrades to Stubbs Park located in the City of Centerville; and

WHEREAS, the City sought a State grant to assist in the improvements to Stubbs Park; and

WHEREAS, City Council adopted Resolution No. 51-21 on May 3, 2021, which authorized the City Manager to enter into a Capital Improvement Community Park, Recreation/Conservation Project Pass Through Grant Agreement with Ohio Department of Natural Resources (ODNR); and

WHEREAS, the parties to that Grant Agreement intend to amend the agreement to extend the project period.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CENTERVILLE, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:

Section 1. The City hereby authorizes the City Manager to enter into an Amendment to the Capital Improvement Community Park, Recreation/Conservation Project Pass Through Grant Agreement with Ohio Department of Natural Resources (ODNR) for the funding of \$784,000 towards the Stubbs Park Improvements Project, a copy of the Amendment is attached hereto as Exhibit "A" and incorporated herein on behalf of the City of Centerville.

Section 2. This Resolution shall be in full force and effect at the earliest date allowed by law.
