ORDINANCE NO. 05-22
CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Bill Serr ON THE 4th DAY
OF April, 2022.

AN ORDINANCE TO ESTABLISH THE CREATION OF THE CITY
OF CENTERVILLE ONEOHIO FUND.

WHEREAS, Section 5705.09(F) of the Ohio Revised Code establishes separate funds for each class of revenue derived from a source other than the general property tax; and

WHEREAS, Section 5705.10(I) states that money paid into a fund must be used only for the purposes for which such fund is established; and

WHEREAS, Section 5705.12 grants permission to the taxing authority of a subdivision to establish special funds; and

WHEREAS, the State of Ohio reached an \$808 million agreement with the three largest distributors of opioids, and as such, established the OneOhio Plan as a mechanism to ensure that any money from a negotiated settlement is distributed fairly to the communities hit hardest by the opioid crisis; and

WHEREAS, the OneOhio Plan established a process for distributing funds to local government entities through the states; and

WHEREAS, the City of Centerville shall receive such OneOhio funds from the State of Ohio; and

WHEREAS, the City of Centerville intends to use the OneOhio funds for the purposes allowed by the OneOhio Plan, which are as follows:

1. to expand the availability of treatment for individuals affected by substance use disorders;
2. to develop, promote and provide evidence-based substance use prevention strategies,;
3. to provide substance use avoidance and awareness education;
4. to decrease the oversupply of licit and illicit opioids; and
5. to support recovery from addiction services performed by qualified and appropriately licensed providers; and

WHEREAS, a special fund is needed to properly account for such deposits from the State and related expenditures.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. That there is established the OneOhio Fund, a special revenue fund.

Section 2. That all proceeds from the State of Ohio paid from the OneOhio plan will be received into the OneOhio Fund.

Section 3. That appropriate expenditures from this fund be expended only to cover costs consistent with the requirements of the OneOhio Plan as expressed above and any applicable regulations and guidance pursuant to the OneOhio Plan.

Section 4. This ordinance shall take effect at the earliest time allowed by law.
