**AN ORDINANCE AUTHORIZING THE WRITE-OFF OF THE
UNCOLLECTIBLE ACCOUNTS FOR MOWING CHARGES.**

WHEREAS, the City of Centerville may charge property owners for removal of offensive weeds or grass within the City as set forth in Section 660.14 of the Centerville Municipal Code; and

WHEREAS, Centerville Code Section 660.14 sets forth the process and procedure for the collection of fees for said removal of offensive weeds or grass; and

WHEREAS, diligent efforts are made to collect on delinquent accounts; and

WHEREAS, upon failure of a property owner to pay said fees, such fees may be accessed against the property owner's real estate taxes; and

WHEREAS, it is desirable for the City to continue to clean up old balances and make a determination of said balances which have been deemed uncollectible either because the individuals no longer own the property or are deceased; and

WHEREAS, the City had previously approved legislation to write off uncollectible accounts; and

WHEREAS, it has been determined that these accounts can no longer be or should not be sent to the County Auditor's office due to the fact that that individuals either no longer own the property in the City or because the accounts cannot be collected due to other reasons; and

WHEREAS, the write-off of uncollectible accounts is necessary to provide an accurate measure of the City's financial position; and

WHEREAS, attached to this Ordinance is a listing of uncollectible accounts;
and

WHEREAS, it is fiscally responsible to write-off delinquent accounts that are deemed uncollectible.

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:

Section 1. City Council hereby agrees and acknowledges that it is in the best interests of the City to write-off uncollectible accounts.

Section 2. The City Council recognizes that the accounts listed on the attachment to this Ordinance are uncollectible.

Section 3. City Council hereby authorizes the write off of the uncollectible accounts for fees for removal of offensive weeds and grass as set forth in the attachment.


Section 4. This ordinance shall be effective from and after the earliest date allowed by law.
