**AN ORDINANCE TO AMEND SECTION 452.13, PARKING TIME LIMIT FOR HEAVY VEHICLES; EXCEPTION, OF THE MUNICIPAL CODE OF THE CITY OF CENTERVILLE, OHIO.**

**PREAMBLE AND PURPOSE**

**WHEREAS**, the City of Centerville has enacted regulations in the Centerville Municipal Code to regulate the parking time on streets for heavy vehicles within the City; and

**WHEREAS**, the City intends to revise and update this section of the City's regulations to include large recreational vehicles from exceeding said parking times on City streets.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY ORDAINS:


Section 1. That the following amendment to Section 1060.08 of the Centerville Municipal Code is hereby enacted as follows with new language to be added in *italics* and text to be deleted in ~~strikeout~~ as provided in Section 5.02 of the Centerville Charter:

**452.13 PARKING TIME LIMIT FOR HEAVY VEHICLES; EXCEPTION.**


The parking of all trucks, tractors, ~~and~~ all types of trailers *and recreational vehicles larger than eight feet (8') in height, eight feet (8') in width and twenty-two feet (22') in length* on streets is restricted to two hours, except for emergency and public safety vehicles and delivery service vehicles while engaged in such delivery or service.

Section 2, This ordinance shall be effective from and after the earliest date allowed by law.
