- A. Ordinance 21-22, An Ordinance To Repeal Ordinance Number 16-21 In Its Entirety And To Establish Class Titles, Pay Ranges, Grades, Rates Of Pay, And Regulations For Employees Of The City Of Centerville, Ohio (Set for Public Hearing on October 17, 2022).
- B. A Resolution Authorizing And Directing The City Manager, On Behalf Of The City Of Centerville, To Execute A Vehicle Purchase And Transfer Agreement With The City Of Piqua, Ohio, For The Transfer Of Waste Vehicles, be passed.
- C. A Resolution Authorizing The City Manager On Behalf Of The City Of Centerville To Apply For Miami Valley Regional Planning Commission Grants For Level 2 Electric Vehicle Chargers For Benham's Grove, The Golf Club At Yankee Trace And Stubbs Park And Authorizing The City Manager To Take All Steps Necessary To Enter Into An Agreement Therewith, be passed.
