RESOLUTION NO. 85-22 CITY OF CENTERVILLE, OHIO

SPONSORED BY COUNCILMEMBER Duke Lunsford ON THE 3rd DAY OF October, 2022.

A RESOLUTION AUTHORIZING THE CITY MANAGER ON BEHALF OF THE CITY OF CENTERVILLE TO APPLY FOR FEDERAL INFRASTRUCTURE INVESTMENT AND JOBS ACT FUNDS THROUGH THE MIAMI VALLEY REGIONAL PLANNING COMMISSION AND AUTHORIZING THE CITY MANAGER TO TAKE ALL STEPS NECESSARY TO ENTER INTO AN AGREEMENT THEREWITH.

WHEREAS, the Miami Valley Regional Planning Commission (MVRPC) has solicited local government entities to submit new transportation projects for funding consideration in the Transportation Improvement Program (TIP); and

WHEREAS, the City of Centerville has committed to a timely project development schedule; and

WHEREAS, the City of Centerville will commit the necessary resources to support the estimated local cost portion of the following described project to be submitted to MVRPC, shown in order of the priority from number 1 to 5:

- 1. Centerville Station Road Improvements Project Phase 2 Estimated Local Share \$1,189.968.00
- 2. Main Street Uptown Improvements Estimated Local Share \$1,974,492.00
- 3. Clyo Road and Dimco Way Intersection Improvements Estimated Local Share \$1,786,572.00
- 4. Clyo Road and Bigger Road Intersection Improvements -Estimated Local Share \$802,210.00
- 5. East Franklin Street and Clyo Road Hiker Biker Extension Estimated Local Share \$554,750.00; and

WHEREAS, the City of Centerville requests exemptions from MVRPC's Complete Streets Policy for the proposed project funding applications:

Main Street Uptown Improvements Project (Exemption 8) – Where roadway standards or bicycle and pedestrian standards cannot be met (Cyclist).

NOW THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

- Section 1. The City Manager on behalf of the City is hereby authorized to transmit and submit the application for the following transportation project to MVRPC for funding consideration in the TIP:
 - 1. Centerville Station Road Improvements, Phase 2
 - 2. Main Street Uptown Improvements
 - 3. Clyo Road and Dimco Way Intersection Improvements
 - 4. Clyo Road and Bigger Road Intersection Improvements
 - 5. East Franklin Street and Clyo Road Hiker Biker Extension
- <u>Section 2.</u> The City Manager is hereby authorized to take all steps necessary to execute on behalf of the City, the application for funds as referred to in Section 1 of this Resolution.
- Section 3. The City Manager is hereby directed and authorized to take or cause to be taken all other action necessary and proper to secure the funding sought by the application referred to herein, including, but not limited to entering into any agreements as may be necessary and appropriate for obtaining this financial assistance and providing any additional information sought by the reviewing agencies during the time the application is under review. The City Manager is further directed and authorized to cause compliance with all reporting requirements required by the Miami Valley Regional Planning Commission (MVRPC) as required as part of the funding process.
- Section 4. The City Manager is hereby further authorized to enter into the Cost-Sharing Agreement with the Board of Montgomery County Commissioners for the submittal of an application and for the distribution of funding from a Surface Transportation Program (STP) grant for the Clyo Road and Dimco Way Intersection Improvements and for a joint funding and construction of the Project. The cost-sharing agreement will be processed as a future resolution.
- <u>Section 5.</u> Upon application approval, the City hereby states its commitment to the local contribution for the project as identified in this application, including local contribution of cost exceeding the current estimates or subsequent revised estimates as accepted by the MVRPC.
- Section 6. It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.
- Section 7. This Resolution shall become effective immediately upon its passage.
