### **Public Meeting Space Improvement**

Mr. Bills provided renderings of the design concept, the architectural plans, an explanation of the bid process, including an explanation of the alternates, and the bid results.

Council members discussed the furnishings, ADA compliance, potential cost savings regarding the lighting, the parameter of project options, project timeframe, and technical and power upgrades.

Mr. Bills and Mr. Bowden left the meeting at this time.

#### **Executive Session**

At 5:23 p.m., Mr. Lunsford made a motion to move into Executive Session for a conference with an attorney for the City, concerning disputes involving the City that are the subject of pending or potential court action, for personnel to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee, or official, and for real estate to consider the purchase of property for public purposes . Mrs. Rau seconded the motion, and it passed 6-0 in a roll call vote.

Mr. Palcher joined the meeting at this time.

At 7:14 p.m., after no official business was conducted, Mrs. Rau made a motion to move out of Executive Session. Mrs. Kenley seconded the motion, and it passed 7-0 in a roll call vote.

### Benham's Grove Update

Mrs. Vogelgesang provided an explanation of the background and process which lead to staff's analysis of the potential return on investment (ROI) for the improvements at Benham's Grove. Mrs. Bostdorff discussed the ROI assumptions, costs versus benefits, and pricing expectations.

City Council members discussed economic concerns and project prioritization.

Mrs. Vogelgesang requested input into next steps regarding the design phase. Council members indicated their interest in moving forward with the design phase. Staff will bring an action item to City Council at the November 7, 2022 meeting.
