A RESOLUTION ACCEPTING THE BID SUBMITTED BY STEP CG, LLC OF COVINGTON, KENTUCKY FOR THE 2022 TRAFFIC SIGNAL SWITCH REPLACEMENT PROJECT (PROJECT TC-1) AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN CONNECTION THEREWITH.

WHEREAS, PEPPM is a national cooperative purchasing program administered by the Central Susquehanna Intermediate Unit that uses the lead agency model for competitively bid contracts; and

WHEREAS, on or about October 3, 2022, the City adopted Resolution #82-22 authorizing the City to enter into a contract with PEPPM to utilize their competitive bid processed for the purchase of products; and

WHEREAS, the City of Centerville received a bid through PEPPM cooperative purchasing program contract pricing, Contract # 528897-087, for Extreme Network, Inc., video surveillance software, according to specifications prepared by the City; and

WHEREAS, under the PEPPM contracting pricing, Extreme Network, Inc. as the manufacturer and Step CG, LLC of Covington, Kentucky, as the installer, was the low and best bidder in the amount of \$123,748.21.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1. That the bid submitted by Step CG, LLC of Covington, Kentucky for the 2022 Traffic Signal Switch Replacement Project (Project TC-1), is hereby accepted in the amount of \$123,748.21. The City Manager is hereby authorized to expend up to an additional \$12,000.00 for additional work if necessary, making the total amount approved \$135,748.21.

<u>Section 2</u>. That the City Manager is hereby authorized to do all things necessary to execute a contract with Step CG, LLC of Covington, Kentucky, as stated above.

<u>Section 3.</u> This resolution shall become effective at the earliest date
allowed by law.
