The meeting was opened with an Invocation by Pastor Jon Gibson of Living Hope Church, followed by The Pledge of Allegiance to the flag with Deputy Mayor Rau presiding. Mr. Lunsford made a motion for approval of the minutes, Mrs. Kenley seconded the motion, and it passed with 6 ayes.

Communications

Mrs. Davis reported no communications.

Recognitions

- A. Mrs. Rau read a Certificate of Congratulations to the Centerville High School Girls Golf team for its State Championship win. Coach Michael Dalton spoke about the team's awesome season, noting it was the first championship win in 27 years. Each team member introduced themselves and expressed appreciation for the coach, each other, and the recognition.
- B. Mrs. Rau read a Certificate of Congratulations to the Centerville High School Girls Doubles Tennis team for its second consecutive State Championship win. Coach Scott Long praised the team members as a *fantastic young duo*. Each team member introduced themselves and expressed appreciation for the recognition.

Presentations

- A. Auditor of State Auditor of State West Regional Liaison Joe Braden presented Mr. Roark with the 2021 Auditor of State Award with Distinction. He explained the criteria required to achieve the award for accounting excellence and fiscal integrity and noted very few municipalities qualify for the honor. Mr. Roark praised the staff effort and particularly noted Mrs. Piatt's contributions to ensure the Finance Department performed using best practices. He expressed his excitement for receiving the award.
- B. Greater Dayton Regional Transit Authority Communications and Training Director Jessica Olson provided a presentation of the agency offerings. She discussed the organizational facts, the 50 year celebration event, recruitment, partnerships, pay options, fleet, services, and the system redesign. She noted the agency is researching the implementation of a route near Clyo Road. Deputy Mayor Rau thanked her for the presentation.

Officials' Reports

Mrs. Kenley informed about a recent event called *The Dinner Club* at Centerville High School, providing networking opportunities to students. She noted it was a very positive experience.

Mr. Engert advised the Sense of Place books are available and encouraged everyone to consider purchasing the book as a gift.

Mr. Engert discussed Centerville –Washington History's new podcast program.

Mr. Engert advised that the Centerville High School winter athletic programs are underway and encouraged attendance at the various games and matches.

In the City Manager's Report, Mr. Davis spoke about:

- GovTech meeting earlier today discussing the aggregation program which now includes 18 jurisdictions

- Wished a safe and happy Thanksgiving to all

Deputy Mayor Rau praised and thanked Drew Simon, Kate Bostdorff, and all of staff for their efforts on the tree lighting event.

Old Business

A. PUBLIC HEARING: Ordinance 23-22, An Ordinance Amending The Centerville Municipal Code Section 1062.02, Hours Of Operation, For Municipal Parks In Order To Allow Increased Hours In The Cornerstone Park.

Mr. O'Brien presented the background and the proposed legislation.

Mrs. Vogelgesang advised closing on the park property is awaiting signatures on the maintenance agreement and signing off on the few remaining punch list items.

Deputy Mayor Rau opened the Public Hearing. Hearing no one come forward, Deputy Mayor Rau closed the Public Hearing.

Mr. Serr sponsored Ordinance 23-22 and moved for its adoption. Mr. Palcher seconded the motion, and it passed with 6 ayes.

- D. Resolution 105-22, A Resolution Accepting The Bid Submitted By Step CG, LLC Of Covington, Kentucky For The 2022 Traffic Signal Switch Replacement Project (Project TC-1) And Authorizing The City Manager To Enter Into A Contract In Connection Therewith.
- E. Resolution 106-22, A Resolution By The Centerville City Council Imposing A Temporary Moratorium On The Operation Of Any Short Term Residential Real Estate Rentals In The City Of Centerville, Ohio, For A Period Of Twelve Months (365 Days) To Allow City Council Time To Study And Review The Long-Term Impact Of Such Short Term Residential Real Estate Rentals.
- F. Resolution 107-22, A Resolution Accepting The Bid Submitted By Step CG, LLC Of Covington, Kentucky For The Citywide Security Camera Upgrade Project And Authorizing The City Manager To Enter Into A Contract In Connection Therewith.

Mr. Engert requested an explanation of the changes in the golf fees. Mrs. Vogelgesang explained the significant changes include right-sizing fees for the driving range, youth lessons, and the new golf cars.

Mr. Serr sponsored the Consent Agenda and moved for its approval. Mr. Lunsford seconded the motion, and it passed with 6 ayes.
