A. PUBLIC HEARING: Application C-2022-0002: Appeal the Decision of the Planning Commission to Uphold the Decision of the Zoning Administrator to Deny the Certificate of Zoning Compliance (Z-2022-0237) for the Two Parcels Located at 6238 and 6240 Far Hills Avenue for a Valvoline Retail, Oil Change Business. Applicant: Casto, c/o Development Group, Eric Leibowitz.

Location: 6238 Far Hills Avenue (Parcel 068 00308 0028) and 6240 Far Hills Avenue (Parcel 068 00308 0041).

Mayor Compton advised that the applicant had requested the item be tabled until January 23, 2023.

Mrs. Rau made a motion to remove the item from the previous tabling on December 5, 2022, Mr. Lunsford seconded the motion, and it passed with 5 ayes.

Mr. Lunsford made a motion to table the public hearing until January 23, 2023, Mrs. Kenley seconded the motion, and it passed with 5 ayes.

B. PUBLIC HEARING: Ordinance 01-23, An Ordinance Approving The Editing And Inclusion Of Certain Ordinances And Resolutions As Parts Of The Various Component Codes Of The Codified Ordinances; Providing For The Adoption And Publication Of New Matter In The Updated And Revised Codified Ordinances; And Repealing Ordinances And Resolutions In Conflict Therewith.

Mr. Liberman explained this legislation is the City's annual update to its official Code book, incorporating the City's Ordinances and any State law changes.

Mayor Compton opened the Public Hearing. Hearing no one come forward, Mayor Compton closed the Public Hearing.

Mr. Engert sponsored Ordinance 01-23 and moved for its adoption. Mrs. Kenley seconded the motion, and it passed with 5 ayes.

Mayor Compton turned the attention of the group to the Consent Agenda. Any City Councilmember may remove an item from the Consent Agenda by request. No second is required for removal of an item. Mrs. Rau sponsored the Consent Agenda, with the exception of Item C and moved for its approval. Mr. Lunsford seconded the motion, and it passed with 5 ayes.

Action on Consent Agenda Item C

Mayor Compton read Item C into record as follows:

C. Resolution 07-23, A Resolution Authorizing The City Manager To Enter Into An Electric Vehicle Charger Project Partner Agreement With The Miami Valley Regional Planning

Commission For Electric Vehicle Chargers To Be Located At Benham's Grove And Stubbs Park.

Mr. Davis explained this legislation authorizes grant agreements with the Miami Valley Regional Planning Commission (MVRPC) to install Electric Vehicle Charging Stations in Stubbs and at Benham's Grove.

Mr. Engert expressed concerns with the location of the charging station at Stubb's Park due to the park being closed at night and due to vandalism trends surrounding these charging stations. He further noted that a charging station would be more appropriate at Cornerstone North.

Mrs. Bostdorff explained MVRPC has approved the Stubb's Park and Benham's Grove locations. The City has been unable to find a business at Cornerstone North to partner with in order to have parking spaces available for the charging stations. She will reach out to Costco.

Council members discussed regular charging stations versus the super charging stations (no funding available for the super chargers at this time), the need for any electrical upgrades at the two facilities, repair and replacement cost responsibilities, and the specific locations of the charging stations within the facilities.

Chief Brown indicated he would research to see if vandalism to charging stations is on the rise; the Police Department provides extra patrol to these areas routinely.

Mr. Liberman noted the agreements provide liability coverage and repair and replacement coverage from MVRPC for five years.

Mrs. Rau sponsored the Consent Agenda Item C and moved for its approval. Mrs. Kenley seconded the motion, and it passed with 5 ayes.

With no further business before the Council, Mayor Compton adjourned the regular meeting at 8:21 P.M. to reconvene in Work Session. The next regular meeting of City Council is scheduled to take place on Monday, January 23, 2023, at 7:30 P.M.
