**A RESOLUTION AUTHORIZING THE CITY MANAGER  
TO EXECUTE THE LETTER OF ACCEPTANCE OF THE  
MONTGOMERY COUNTY SOLID WASTE DISTRICT'S  
WASTE REDUCTION & RECYCLING GRANT.**

**WHEREAS**, in October 2022, the City of Centerville submitted a grant application to the Montgomery County Solid Waste District for grant funding for the purchase of Bigbelly Solar Dual Waste and Recycling Kiosks (the "Project"); and

**WHEREAS**, the Project was selected to receive funding from the Montgomery county Solid Waste District Waste Reduction & Recycling grant funds; and

**WHEREAS**, the City adopted Resolution No. 81-22 on October 3, 2022, approving the City's application for the grant; and

**WHEREAS**, the City was awarded a 2023 Montgomery County District Incentive Grant for the County's share of \$28,447.65, plus the City's contribution which amounts to a total grant award of \$40,639.50; and

**WHEREAS**, the City's match contribution is \$12,191.85; and

**WHEREAS**, the County requests that the City accept the award.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF  
THE CITY OF CENTERVILLE, MONTGOMERY COUNTY, OHIO, AS  
FOLLOWS:**



## LETTER OF GRANT ACCEPTANCE

This Letter of Acceptance is agreed to by Mr. Wayne Davis as a representative of City of Centerville, hereinafter referred to as a recipient participating in Montgomery County Solid Waste District's Waste Reduction & Recycling Grant Program.

**WHEREAS**, the Montgomery County Solid Waste District is committed to integrated waste management techniques, including education, outreach, waste reduction, recycling, composting, litter prevention, illegal dumping and community beautification and;

**WHEREAS**, the purpose of the Waste Reduction & Recycling Grant Program is to provide funding for local governments to effectively increase participation in education, outreach, waste reduction, recycling, composting, litter prevention, illegal dumping and community beautification efforts and community programs, and;

**WHEREAS**, the following terms and conditions shall govern participation in the Waste Reduction & Recycling Grant Program:

1. All grant funds must be used for the approved activities set forth in the Award Letter.
2. The grant recipient will provide the initial funds to operate specified programs. The Solid Waste District will reimburse recipient upon receipt of proof of paid invoice(s) for approved activities, not to exceed the amount set forth below.
3. Grant recipient must submit a summary report of all approved activities at the end of the project or by October 31, 2023, whichever is earlier.
4. To be eligible for further rounds of grant funding, grant recipient must submit 2022 recycling data for Ohio EPA Annual Report by February 28, 2023.
5. Grant recipient must provide applicable maintenance, insurance and liability for equipment purchased with grant funds.
