Mr. Spencer called the meeting to order at 8:45 A.M.

Mr. Kenning distributed the minutes from the August 15, 1977 meeting. Mr. Spencer made a motion to approve the minutes. Mr. Sweetman seconded.

Mr. Kenning started the review of the proposed 5 Year Capital Improvement Program.

Mr. Kenning advised the committee that our fleet of snow removal equipment was down to two reliable trucks. He recommended going to bid and purchasing the equipment listed in ME-4 and ME-7, (2 salt spreaders and 3 dump trucks with related snow removal equipment) in 1977 to have in time for this years snow removal season. The cost of such equipment, approximately \$100,000, would be paid for through a bond-anticipation note to be paid off in 1978. Mr. Kenning stated that this was a pre-budget committment of 1978 revenues which would have to be earmarked specifically for the payment of the bond-anticipation note.
