Mayor Compton called the Work Session meeting to order at 5:09 P.M.

Benham's Grove Update

Mrs. Schindler advised that the project is approaching final design and that any last design changes need to be discussed tonight.

Mr. Fabelo presented the current site plan, noting that surveys have been completed and the site has been staked. He discussed parking delineation between the two sections of the campus, pedestrian enhancements, the building color palette, the interior improvements to the Gerber building, and the renovation of the barn. Mayor Compton inquired about flooring concerns in the Gerber House. Mr. Fabelo indicated they will take measures to mitigate the flooring issues.

Mr. Fabelo then discussed the event center, providing renderings, interior architecture

design specifications, and mechanical needs. Mr. Serr expressed concern with the lack of an elevator for the upstairs bridal suite and noted the need to address ADA compliance. Further discussion led to a request to include an elevator to the design.

Mr. Palcher joined the meeting via phone at this time.

Mr. Fabelo presented elevations and discussed roofing materials, noise mitigation, and the interior elements. Council members discussed weather contingencies and drainage.

Mr. Fabelo reviewed the project timeline and current cost expectations.

CCIC Annual Review

Mr. Erik Collins provided a binder of informational materials and discussed the purpose of CICs, membership of the Centerville CIC, a 2022 project recap, the 2023 programming budget, outreach measures, and resource partnering.
