Mayor Compton thanked the participants of the Uptown Open House.

Mayor Compton advised there is an exciting spring and summer event lineup in the works.

Mrs. Rau discussed the CCIC meeting held last week; the Board is considering a new residential assistance program for this year.

Mr. Engert advised the next installment of the Centerville-Washington History Speaker Series, scheduled for tomorrow March 21, 2023 at RecWest, features Hylda Strange speaking about the Crosley Brothers.

Mr. Engert touted the successes enjoyed by the Centerville High School winter athletic teams the arts groups, and the scholastic teams.

Mr. Lunsford advised the Americana kick-off meeting was held last week. The next meeting is scheduled for April 4, 2023. The committee has selected *Duty, Honor and Sacrifice, Saluting our Community's Heroes* as this year's festival theme.

Old Business

A. PUBLIC HEARING: For the City of Centerville electric and gas aggregation operation and governance plans.

Mayor Compton opened the Public Hearing.

1. Ms. Amy Hoffman representing Palmer Energy discussed the program's expected participation level, how recommendations will be made after the bidding process, notifications to eligible residents and businesses.

Council members discussed plan term, individual actions for both the opt-out or opt-in process, and Palmer Energy's experience in managing aggregation plans.

- 2. Mr. Karl Bierman of 1175 Ambridge Road addressed City Council in favor of the aggregation plan and to thank City Council and staff for its efforts.
- 3. Mr. Marshall Goodfellow of 40 Peachgove inquired if there will be an clean energy options.
 - Ms. Hoffman indicated she thought there would be.

Hearing no one else come forward, Mayor Compton closed the Public Hearing.

B. PUBLIC HEARING: Ordinance 03-23, An Ordinance Approving Individual Assessments Amounts And Directing The Director Of Finance Or His Designee To Certify The Amounts To The County Auditor For Collection.

Mrs. Piatt reviewed the addresses and the total amount to be assessed.

C. PUBLIC HEARING: Ordinance 04-23, An Ordinance Authorizing The Write-Off Of The Uncollectible Accounts For Mowing Charges.

Mrs. Piatt advised the write-off involves one parcel, which is under new ownership.

Mr. Serr sponsored Ordinance 04-23 and moved for its adoption. Mrs. Rau seconded the motion, and it passed with 6 ayes.

Mrs. Rau sponsored the Consent Agenda with the exception of Item C and moved for its approval. Mr. Lunsford seconded the motion, and it passed with 6 ayes.

Action on Consent Agenda Item C

Mayor Compton read Item C into record as follows:

C. Resolution 31-23, A Resolution Approving The Plan Of Operation And Governance For The Miami Valley Communications Council Electric And Natural Gas Aggregation Program, For The Purpose Of Jointly Establishing And Implementing An Electric And Natural Gas Program For The City Of Centerville.

Mr. Engert advised although he is in favor of aggregation, he is opposed to implementing the plan as an opt-out program and will vote no for that reason.

Mr. Serr sponsored Consent Agenda Item C and moved for its approval. Mrs. Kenley seconded the motion, and it passed 5-1 in a roll call vote with Mr. Engert voting no.
