RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A FIRST AMENDMENT TO AGREEMENT FOR PURCHASE AND SALE WITH THE BOARD OF EDUCATION OF THE CENTERVILLE CITY SCHOOL DISTRICT FOR THE PURCHASE OF APPROXIMATELY SIX ACRES OF VACANT LAND PLUS OR MINUS LOCATED IN THE CITY OF CENTERVILLE.

WHEREAS, Council and the Board of Education of the Centerville City School District previously entered into an Agreement for Purchase and Sale of property dated June 9, 2022; and

WHEREAS, said Agreement set forth time periods for completion of various items; and

WHEREAS, the parties desire to extend the Due Diligence Period of the Agreement to allow additional time for the parties to work on additional aspects of the purchase; and

WHEREAS, Council has the power to enter into such real property purchase agreement by virtue of its Charter and the provisions of Article VIII, Section 16 and Article XVIII, Section 3 of the Ohio Constitution.

NOW, THEREFORE, THE MUNICIPALITY OF CENTERVILLE HEREBY RESOLVES:

Section 1: That the City Manager is hereby authorized to execute on behalf of the City, the First Amendment to Agreement for Purchase and Sale with the Board of Education of the Centerville City School District for the purchase of property located in the city of Centerville upon terms and conditions substantially similar to those terms set forth in the amendment. Said amendment is marked as Exhibit "A" and incorporated herein.

Section 2: That this resolution shall go into effect at the earliest time allowed by law.

FIRST AMENDMENT TO AGREEMENT FOR PURCHASE AND SALE

THIS FIRST AMENDMENT TO AGREEMENT FOR PURCHASE AND SALE (this "Amendment") is by and between the BOARD OF EDUCATION OF THE CENTERVILLE CITY SCHOOL DISTRICT, Montgomery County, Ohio, a city school district and political subdivision of the State of Ohio ("Seller"), and the CITY OF CENTERVILLE, OHIO, a City and political subdivision in and of the State of Ohio ("Purchaser") pursuant to Ohio Revised Code 3313.41(C), under the circumstances summarized in the following recitals:

- A. Pursuant to an Agreement for Purchase and Sale entered into by Seller and Purchaser dated June 9, 2022 (the Agreement for Purchase and Sale hereinafter referred to as the "Purchase Agreement"), Seller agreed to sell, and Purchaser agreed to purchase the Property identified in the Purchase Agreement consisting of an approximately 6+/- acre portion of the real property identified in the Official Records of Montgomery County, as Parcel Number O68-00304-0074.
- B. The parties have determined that they will require additional time to complete the purchase to allow for the City to acquire the necessary rights to the Dimco Way Connection as depicted in Exhibit C of the Purchase Agreement.

NOW, THEREFORE, for valuable consideration paid, the receipt and sufficiency of which are hereby acknowledged, Seller and Purchaser agree as follows:

- 1. The expiration of the Due Diligence Period as set forth in Section 3.2 of the Purchase Agreement is extended until 11:59 p m on July 31, 2023.
- 2. Purchaser acknowledged and agrees that the Purchaser has obtained the Commitment as set forth in Section 4.1 of the Purchase Agreement.
- 3. In Section 5.5.3 of the Purchase Agreement, the reference to "Exhibit C" is changed to "Exhibit A".
- 4. In Section 9.2 of the Purchase Agreement, the second sentence of the first paragraph is amended to read as follows: "Purchaser shall be responsible for securing the necessary title, easement or access rights to access the Dimco Way Connection property as depicted in Exhibit C."
- 5. Except as amended hereby, the Purchase Agreement is ratified and confirmed and remains in full force and effect. In the event of an inconsistency between the provisions of this First Amendment and the Purchase Agreement, then the following order of priority shall control: this First Amendment and the Agreement for Purchase and Sale.
- 6. This Amendment is effective as of the date last signed by the Purchaser or Seller. This Agreement may be signed in several counterparts and, together, shall constitute one document. Facsimile copies of signatures or digitally scanned signatures are acceptable to evidence complete agreement.
